Course abstract:

The course, part of the **Master in Technologies for the Development of European Projects**, has been designed to analyse the best practices in the utilisation of European funds for the **implementation of projects in different thematic areas**. Experienced professionals will give to the attendants technical and practical advices of **how to draft a successful project proposals and how to develop their current and future projects** in the field of environment, research & innovation, information and communication technologies, competitiveness of enterprises, public administration, education, youth, culture, citizenship, media, tourism, rural development, regional growth and neighbouring partnerships.

The course also includes a specific focus **on the case histories in utilisation of European funds at regional level.** The results and the impact of the most relevant European projects implemented at regional level will be presented and discussed by the representatives of the regions of the EU Member states, acceding country (Croatia will be the next EU Member state by 1st July 2013) and candidate and potential candidate countries.

The third part of the course is addressed to explain the **EU SME policy** and understand how the lobbying actions influence the **EU policy-making process**. During the **study visit at the EU parliament and European Economic and Social Committee** there will be also the opportunity to get familiar with European Institution's environment.

The **teaching methodology** combines traditional in-class lectures, the analysis of case studies and the **European Projects Simulation on My Europa platform** (<u>www.my-europa.eu</u>) that represents the ultimate methodology for the development of European projects. The European Projects Association (EPA) experts will led the activities on My Europa platform through the learning by doing methodology.
